In order to permit the fair and orderly expression of such comment, the Board shall provide a period for public comment at every regularly scheduled meeting of the Board. Public participation shall be governed by the following rules:

- 1.A participant must be recognized by the presiding officer and must preface comments by an announcement of his/her name, municipality of residence, and group affiliation, if applicable:
- 2. Each statement made by a participant shall be limited to three minutes' duration;
- 3. No participant may speak more than once on the same topic until all others who wish to speak on that topic have been heard;
- 4. All statements, questions, or inquiries shall be directed to the presiding officer and any questions or inquiries directed by a participant to another Board member shall be redirected to the presiding officer who shall determine if such statement, question, or inquiry shall be addressed by the presiding officer on behalf of the Board or by the individual Board member;
- 5. The presiding officer may: a. Interrupt, warn, and/or terminate a participant's statement, question, or inquiry when it is too lengthy;

1. Motion to approve the following resolution:

WHEREAS, the Kingwood Township Board of Education recognizes school staff and Board members will incur travel expenses related to and within the scope of their current responsibilities and for travel that promotes the delivery of instruction or furthers the efficient operation of the school district; and

WHEREAS, N.J.S.A. 18A:11-12 et seq. requires Board members to receive prior approval of these expenses by a majority of the full voting membership of the Board and staff members to receive prior approval of these expenses by the Superintendent of Schools and a majority of the full voting membership of the Board; and

WHEREAS, a Board of Education may establish, for regular district business travel only as described in NJOMB Circular Letter 06-14, including amendments or revisions thereto, a threshold amount below which Board approval is not required; and

WHEREAS, the Board of Education establishes, for regular district business travel only, an annual school year threshold of \$150.00 per employee as described in N.J.A.C. 6A:23A-7.3B and where prior Board approval shall not be required unless this annual threshold is exceeded in a given school year (July 1 through June 30); and

WHEREAS, the Board of Education finds that a mileage reimbursement rate equal to that of the NJOMB mileage reimbursement rate is a reasonable rate: and

THEREFORE BE IT RESOLVED the Board of Education approves the amounts set forth for regular district business travel and statutorily authorizes travel expenditures, provided that such expenditures are within the annual maximum travel expenditure amount.

3. Motion to approve an Enrollment Adjustment for the 2024-2025 School Year:

WHEREAS, N.J.A.C. 6A:23A-11.2(c) allows a district to request an adjustment to the tax levy for increases in enrollment that exceeds the state projections in the pre-budget year, and

WHEREAS, the district realized an increase in enrollment of 12.23% which generated an enrollment adjustment in the amount of \$632,828.00, and

WHEREAS, the Kingwood Township Board of Education has determined that there is a need to use a portion of the enrollment adjustment in the amount of \$133,350.00 for the purpose of supporting a thorough and efficient education which has become more difficult as a result of state aid, CPI and exceeding the 2% tax levy cap in the amount of \$125,661.00, and

WHEREAS, the unused portion of the enrollment adjustment \$515,700 will become banked cap for the ensuing four year period, and

NOW THEREFORE BE IT RESOLVED, that the Kingwood Township Board of Education requests the approval to use the enrollment adjustment in the 2024/2025 budget which will exceed the 2% tax levy cap in the amount of \$125,661.00.

BE IT FURTHER RESOLVED, that the purpose for needing the enrollment adjustment will be satisfied during the 2024/2025 budget cycle.
